General Conditions of Sale

This contract is exclusively related to an automatical negotiation on a proper e-commerce website: www.lititalia.it . It is regulated by a legislative decree n°206 from 06.09.2005, particularly in the articles:

Art n°52 it points the information that must be given to the consumer

Art n°53 it anticipates the written confirmation of the information

Art n° 54 it establishes the performance termination of the information

Artn°55 it establishes the exclusions that is to say the cases in which the previous articles or parts of these one did not imposed.

Art n°64 it anticipates the withdrawal right.

The customer declares in reading the document and entirely accepting the whole general conditions , renouncing explicitly to the contestation right of the validity adducing as unique reason the fact that it was stipulated by an electronic connection.

1) Purchase formality

By an answer to the e-mail address communicated by the customer, it is confirmed the correctly reception of the order by Liti Master s.a.s. This mail will contain an order number that it could be used for each following communication; besides the customer engages itself to verify the correctness of your own personal datum and to opportunely communicate the possible correction.

2) Payment Formality

3) Formalities and Delivery Charges

It is valid for Italy and Ue State Members. For other destinations will be communicated during the order proposal . Liti Master s.a.s draws invoice for each delivered order so it will be valid only the information given by the customer during the order. On the national territory island included , charge transport will be at customer expense of about euro 9 plus value added tax and included assurance until one kilo weight (the cost for superior weights will be communicated each time). For Ue nations, charge transport will be at customer expense of about 11 euro plus value added tax including assurance until one kilo weight (the cost for superior weights will be communicated each time). The customer during the delivery must control the wholeness packaging also in the packaging material's fastening. Possible damages must be immediately challenged to the post office that carries out the delivery. Once you have signed the post office's document , the customer could not do challenge about the external features of the packaging delivered.

4) Withdrawal right

Belt's production will be realised after 7 days from payment reception that is to say passing the terms for possible customer afterthought. The delivery will be carry out with postal insured to the customer address in 10 days. According to the art 55, paragraph 2 letter d from legislative decree 06.09.2005 n°206. It is excluded the customer's withdrawal right foreseen from art. 64 of the same legislative decree, so it dealt with goods, leather belts, studs in brass personalized according to customer's demand made in a unique model.

In the case of faulty goods or not conform to the order, the claim must be sent by registered letter with receiving's announcement within 10 days from goods reception, addressed to: Liti Master s.a.s road D. Ricci $n^{\circ}6$ 05021 Acquasparta (Terni). Within 48 hours from the receiving's registered letter, customer service will communicate also by mail the formality of restitution in each case at the customer expense; the consignment, postal assurance until the occurred payment certificate, it

is under the complete customer responsability. The purchase good must be entire and given back in a original packaging according to law rule. When it will be check, the good is no really conforming to the order or with a original dearth it will be replace with any costs at customer expense.

Enforceable Law

Sale contract between the Customer and Liti Master s.a.s is understand concluded in Italy and regulated by Italian Law. For the civil/penal dispute resolution, deriving from the conclusion of this long way sale contract, the territorial competence is established and accepted from both parts exclusively by Terni's juridical Court.

Privacy Informative

In any case they are not assigned to other person according to the normative in matter of personal datum, regulated by privacy code so that the legislative decree $n^{\circ}196$ from 30/06/2003.
